Supervisor's Report: Mark Emerson

Stated that sales tax money can be used in the A or DA funds as long as sales tax funds are used in the B and DB funds first; the B and DB do not have real property tax levy, and there is excess sales tax revenue after these funds are fully funded/supported. Any excess funds could then be used in the A or DA funds.

We received \$221,853.63 in sales tax for 2024

In January 2025 we received \$41,866.62 in sales tax
