**Solar Project:** Fred Whiting made a motion to move forward with the solar farm Special

Use Permit stating there were only 122 signatures out of 2200 people in

the Town on the petition.

Discussion on the solar project, in conflict with the Master Plan and violates the Comprehensive Plan. Could the Special Use Permit be re-

addressed as it needs to meet the 6 criteria.

**Motion** made by Fred Whiting and seconded by Laura Torres to rescind the Special Use Permit and table it for one month. Motion carried 3-1 with

**NAY** from Douglas Wilson and George Ackley absent.

Chairman Whiting called for one person to speak at a time and not over talk people.

**Morgan:** We are here to vote on the preliminary site plan for the trash transfer

station.

DEC required specific criteria for storm water ponds.

Mr. Zoma stated that water samples would be taken; there is no runoff, and it is a closed system, water does not go out of building and when garage floor is washed the water is put in approved holding tank then

pumped out and disposed by a disposal company.

Cayuga County trash only; Mr. Morgan will need to re-route his trucks so

that no other county trash is picked up.

Mr. Blair stated that we are here for the preliminary site plan.

Motion made by be Fred Whiting and seconded by Richard Burke to approve the Preliminary Site Plan with the following amendments:

Cayuga County Trash only and proper entrances to the transfer station.

Motion carried 3-1 with NAY from Douglas Wilson and George Ackley absent.
